INSTRUCTIONS FOR DEER LANDOWNER LICENSES

1. Landowner license applications will not be accepted by the Wyoming Game and Fish Department without the approval of the game warden within whose district the areas being applied for are located. To help verify that you are eligible as a landowner applicant, please complete the following:

* Legal description of the deeded land which entitles you to this license (section, range, township)

* Is this land held as: an individual? a corporation? a trust? a partnership? a limited liability company?
 joint tenancy or tenancy in common or tenancy by the entirety?

* If you are a member of the landowner's immediate family, what is the name of the landowner to whom you are related?

INSTRUCTIONS FOR COMPLETING REDUCED PRICE DOE/FAWN DEER APPLICATION

This application is to be used to apply for a Reduced Price Doe/Fawn Deer license. This license is in addition to any General or Limited Quota Deer license that you may have drawn. No more than a maximum of two (2) Reduced Price Doe/Fawn Deer licenses may be received in the drawing. Those applicants who have not received their maximum of two (2) Reduced Price Doe/Fawn Deer licenses, in the initial drawing, must wait to see if any of those licenses remain after the drawing. If licenses remain after the drawing, they may be purchased in the field from designated License Selling Agents beginning August 15th.

WARNING

A PERSON MAY APPLY FOR A REDUCED PRICE LICENSE WITHOUT APPLYING FOR A FULL PRICE LICENSE. THE DRAWING FOR FULL PRICE DEER LICENSES IS INDEPENDENT OF THE DRAWING FOR REDUCED PRICE DOE/FAWN DEER LICENSES. THE POSSIBILITY EXISTS THAT YOU COULD DRAW A REDUCED PRICE DOE/FAWN DEER LICENSE IN A DIFFERENT HUNT AREA THAN YOU DRAW YOUR REGULAR DEER LICENSE. IF CONCERNED THAT YOU MAY RECEIVE LICENSES IN DIFFERENT HUNT AREAS, ONLY APPLY FOR A SINGLE HUNT AREA IN THE REGULAR DEER DRAWING AND THE REDUCED PRICE DOE/FAWN DEER DRAWING.

ONCE ISSUED, NO REFUNDS WILL BE MADE FOR THE LICENSE(S).

YOUTH REQUIREMENTS

To be eligible for a youth big game license, an applicant must be at least 11 years of age at the time of application, have not reached their 18th birthday at the time of application, and be at least 12 years of age while in the field hunting.

PERSONAL DATA ELEMENTS

Please use the following abbreviations when completing your application:

EYES: Brown-BR, Blue-BL, Hazel-HZ, Green-GR, Gray-GY HAIR: Brown-BR, Blonde-BL, Black-BK, Gray-GY, Red-RD, Bald-BD, White-WH

HEIGHT: Enter as Feet and Inches

SUFFIX: Examples are Jr., Sr., I, II, III, IV
